## SECTION 4: First aid measures

## Description of first aid measures

General information Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.

**Inhalation** Remove affected person from source of contamination. Move affected person to fresh air and

## Appropriate engineering controls

Provide adequate ventilation. Personal, workplace environment or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment. #### Hand protection
