

Appropriate engineering controls	Provide adequate ventilation. Personal, workplace environment or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment. Repeated exposure to chemicals will degrade the ability of the glove to provide resistance to chemicals.
