**SECTION 4: First aid measures****Description of first aid measures**

<b>General information</b>	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.

**SECTION 5: Firefighting measures****Extinguishing media**

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. ### Precautions for safe handling

Provide adequate ventilation. Personal, workplace environment or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment.
