#### Advice for firefighters

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. ### Methods for cleaning up

<b>Appropriate engineering controls</b>	Provide adequate ventilation. Good general ventilation should be adequate to control worker exposure to airborne contaminants.
